DEFINITIONS

MCLG (Maximum Contaminant Level Goal)-The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

MRDL (Maximum Residual Disinfectant Level)-The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

GENERAL INFORMATION - Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants.
