#### **DEFINITIONS**

MCL (Maximum Contaminant Level)-The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

MCLG (Maximum Contaminant Level Goal)-The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

RAA-Running Annual Average

LRAA-Locational Running Annual Average

**TT (Treatment Technique)**-A treatment technique is a required process intended to reduce the level of a contaminant in drinking water.

AL (Action Level)-The concentration of a contaminant which, if exceeded, triggers treatment or other requirements, which a water system must follow.

**MRDLG (Maximum Residual Disinfectant Level Goal)**-The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

**MRDL (Maximum Residual Disinfectant Level)**-The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
