# 2022 Water Quality Report

**Dolliver Municipal Water Supply is pleased to present the Water Quality Report, designed to inform you about the quality of water you receive.**

**GENERAL INFORMATION** - Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water posed a health risk. More information about contaminants or potential health effects can be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline (800-426-4791).

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by *Cryptosporidium* and other microbial contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Dolliver Municipal Water Supply is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. ## ADDITIONAL HEALTH INFORMATION

While your drinking water meets EPA's standard for arsenic, it does contain low levels of arsenic. EPA's standard balances the current understanding of arsenic's possible health effects against the costs of removing arsenic from drinking water. EPA continues to research the health effects of low levels of arsenic, which is a mineral known to cause cancer in humans at high concentrations and is linked to other health effects such as skin damage and circulatory problems.

Infants exposed to manganese over 0.3 mg/L may experience learning or behavioral problems. Adults drinking water with manganese levels greater than 1 mg/L for many years may experience impacts to their nervous system, resulting in behavioral changes and other nervous system effects, including slow and clumsy movements.

## SOURCE WATER ASSESSMENT INFORMATION

This water supply obtains its water from the buried sand and gravel of the Buried Sand and Gravel aquifer. The Buried Sand and Gravel aquifer was determined to have low susceptibility to contamination because the characteristics of the aquifer and overlying materials provide natural protection from contaminants at the land surface. The Buried Sand and Gravel wells will have low susceptibility to surface contaminants such as leaking underground storage tanks, contaminant spills, and excess fertilizer application. ## DEFINITIONS

**MCL (Maximum Contaminant Level)**-The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

**MCLG (Maximum Contaminant Level Goal)**-The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

**ppb**-parts per billion

**ppm**-parts per million

**pCi/L**-picocuries per liter

**N/A**-Not applicable

**ND**-Not detected

**RAA**-Running Annual Average

**TT (Treatment Technique)**-A treatment technique is a required process intended to reduce the level of a contaminant in drinking water.

**AL (Action Level)**-The concentration of a contaminant which, if exceeded, triggers treatment or other requirements, which a water system must follow.

**MRDLG (Maximum Residual Disinfectant Level Goal)**-The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

**MRDL (Maximum Residual Disinfectant Level)**-The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

**NTU**- Nephelometric Turbidity Units
